## 1. Summary of Results

Between 22<sup>nd</sup> and 24<sup>th</sup> March 2021 votes for the following were held concurrently:

- 7 Full Time Students' Union Officers
- 2 Elected Student Trustees
- 2 Referenda
- 3 SU Councillor Bye-Elections

#### Referendum:

### 4. Voter Turnout

'Voter turnout' refers to the total number of eligible students who voted in the elections. Voter turnout in these elections was 5479. This is a decrease of 3,904 from 2020, in which voter turnout was the highest number of unique voters ever recorded in Officer Elections at Sheffield Students' Union, at 9383. Voter turnout this year was approximately 17% of the student population, decreasing from 30% in 2020/21.

The fall in turnout this year is attributed to the COVID-19 pandemic. Due to a national lockdown, all elections publicity and candidate campaigning adhered to legal restrictions on limiting transmission. Therefore, the vast majority of campaigning took place via the use of social media. With limited physical means to promote their campaigns, it is likely that visibility among the student body of the elections and candidates was negatively impacted. There was also evidence of lower engagement and fatigue of online activity among students across other areas of SU activity at this point in the year which may also have been a factor.

The fall in turnout may also be attributed to the change in the SU Officer roles following an Officer Roles Review Referendum this year. However, an increase in candidate numbers demonstrates an awareness of the new roles among the student population, and so this is likely not a sole factor for the fall in turnout.

Voter turnout and student population during the past 10 sets of Full Time Officer Elections are given below. (Please note: The University hasn't released final student demographic information on the current or previous academic years, so populations given are approximate).

### 5. Candidates

As the positions being elected this year are different to previous years, a position by position comparison is not possible. However, the overall number of candidates across the Officer and Trustee Elections increased from 32 in 2019/20, 41 this year.

A standard objective for all-student elections is that each position is contested (has more candidates standing than there are vacancies). This objective was achieved for all elections.

### 6. Election Rules and Complaints

The Election Rules (Appendix A) were approved in advance in line with the Students' Union Constitution and Bye-Law 16 Election Regulations. All candidates agreed to the rules as a compulsory requirement, and were required to undertake a rules briefing prior to campaigning.

The Returning Officers received 9 complaints during the elections. This is in comparison with 10 complaints being received during the 2020 Officer Elections. The Returning Officers met at least once per day during the campaigning period and made rulings on all complaints within 1 working day. Of the 9 complaints, 7 were dismissed and 2 upheld. Sanctions ranged from specific actions

such as removing campaign material to a reduction in campaign budget. A standby Election Appeals Committee was convened, pursuant to the Students' Union Constitution, and heard one appeal.

## 7. Notable incidents and Recommendations of the Returning Officers

- **7.1** 3 complaints were received regarding the rule against inducing votes by financial means, 2 of which were upheld where the activity in question was felt to infringe upon the spirit of this rule.
- 7.2 2 complaints of early campaigning were received, and both were dismissed. The rule against campaigning before the announce of candidates is a source of a significant proportion of complaints each year and may require reviewing, for example by having no formal beginning to campaigning, or by having clearer guidance around what constitutes "campaigning" on social media.

- 7.3 Each year difficulties arise due to the unavoidable personal connections between candidates, voters and Returning Officers and conflicts of interest, perceived or actual. During elections, significant time is also required of those acting as Returning Officers. External (non-student) Returning Officers are common across the Student's Union sector. The Students' Union may wish to explore the possibility of implementing an external Returning Officer system in future to limit risk to the organisation and the impact of the above factors upon elections. This would require amending both the Students' Union Constitution and Bye Laws, and could be considered as part of the next set of Constitutional changes which are undertaken.
- **7.4** The Returning Officers noted that at present the process of communicating decisions relating to non-declaration of campaign expenditure is unspecified. This could be made clearer in future elections.

The elections were agreed by the Returning Officers to be fair and properly conducted.
