

The Universities of Sheffield Military Education Committee

Terms of Reference:

1. To provide and develop formal and informal links between the University of Sheffield, Sheffield Hallam University, and the University Service Units in which students of the two Universities are eligible to serve.
2. To promote, in conjunction with the relevant University Service Units, the acquisition by students of military and leadership skills which contribute to their personal development and benefit them in relation to their future employability and place in society.
3. To ensure that students' participation in military activities is not to be detriment of their academic well-being, that their welfare is safeguarded and that an appropriate duty of care is exercised in respect of such participation.
4. To advise and make recommendations on the appointment of commanding officers and senior Honorary personnel in the relevant University Service Units.
5. To advise the Universities on matters of military education, both local and otherwise.
